Data Readiness

Test Load Data Progress

- Test Load 3 started the week of 12/13 and will run through the first week of February
- Test load 3 provided live data
- FRTIB is preparing for the last data conversion test load

Key
Outcomes

- Assets balanced to the unit
- Data key to daily recordkeeping and operations has been converted and validated for more than 7M accounts
- Integrations are in process between the recordkeeping system and the data lake to support processes requiring access to historical data



Payroll Office Readiness

Connection & Interconnection Security Agreements



- All connection agreement activities are on-track to establish required procedures for receiving and processing data from payroll offices
- Draft Interconnection Security Agreements (ISAs) complete for all 20 original "Direct Connect" agencies
- 4 of 20 ISAs are fully signed, the remaining 16 are in-progress (reviewing, finalizing, routing for signature)
- We expect to have all ISAs fully signed by May 1st

Secure Connection Testing

- Secure connection testing activities are in-progress
- > 18 of 20 Secure Connections established and "Hello World" testing complete
- We expect the remaining two connection to be complete by March 1st
- Full Data testing scheduled to begin with agencies in February

Memorandum of Understanding Finalization / Credentialing



Agency user identification and credentialing in-progress

- 92 Memorandum of Understanding (MOU) documents have been signed
- 9 MOUs are pending counter-signature by agency to be finalized
- > 12 MOUs have been identified as needing amendment to update authorizer contact information
- > The need for 2 new MOUs has been identified, drafts are in development
- 141 of 185 Agency authorizers have been ID verified; credentialing is underway
- We expect to have credentialling to be complete by the February 1st

Security



- Full Authority to Operate on track for the end of February
- Conditional Authority to Operate granted in December

Service Readiness

- Executing against the recovery plan / revised schedule for the missed
 System Test Complete milestone
- Functional testing activities underway, majority of which are complete

Over 20 functional components were tested in December, including fund transfers and reallocations, beneficiary designations, loans, distributions and payments, and the mutual fund window

Remediating items identified during User Acceptance Testing

There were 30 known defects (0 critical) across all functionality entering UAT with an additional 15 defects identified (0 critical) during UAT. To date, 7 of these items have been closed, 6 are under review, and the remaining items are in process of being resolved. 35 additional changes and enhancements were requested during UAT, 16 of which are being deferred or closed and 19 of which are being assessed*

Participant Communications

- Completed participant communications strategy and plan
 - Participant communications will be distributed through a variety of channels, including US Mail, e-mail, Social Media, TSP.gov, and a digital information sharing kit that will be available to trusted third parties



- Annual Executive Director letter announces service provider transition
- First participant communications campaign ("Get Excited") to launch in February
 - This will be followed by two additional campaigns prior to go-live: Get Ready (mid-March) and It's Here (upon go-live)
- Contingency communication plans are also being developed
