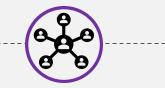

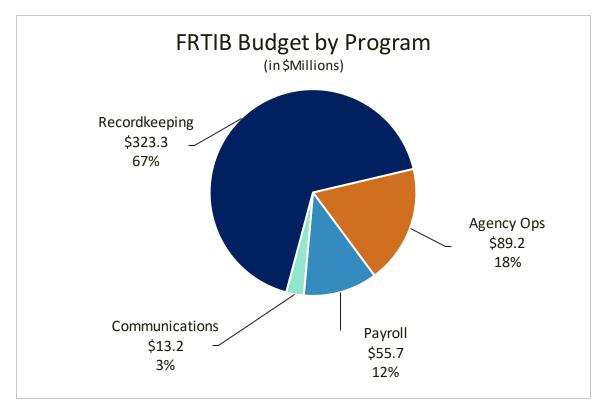

Managed ~\$761B Average Assets for 6.8M participants

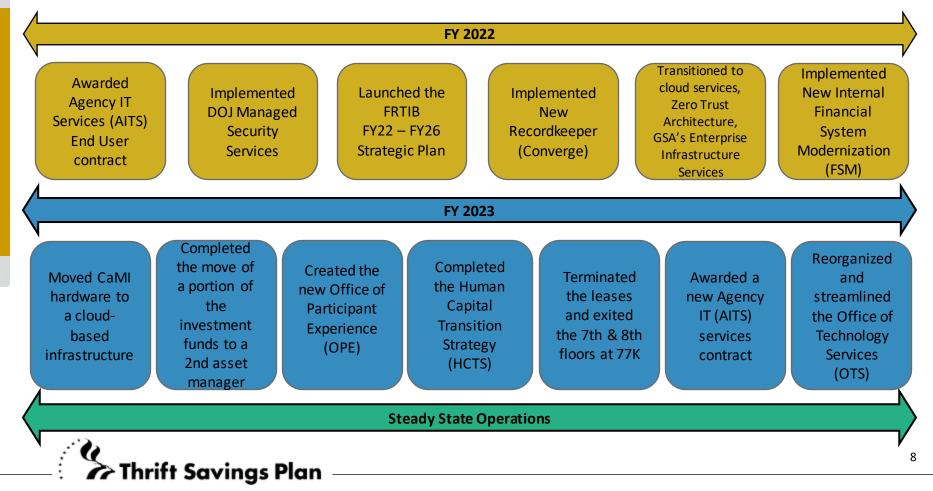

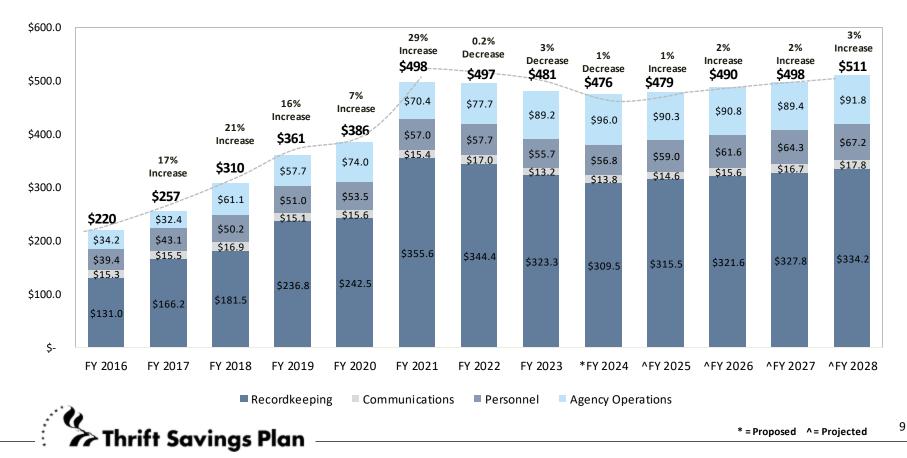

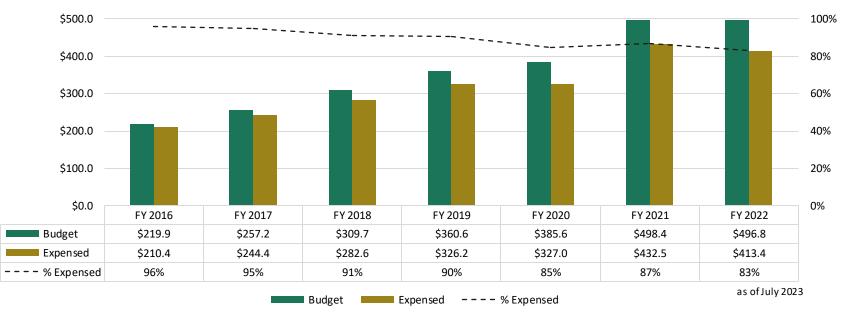

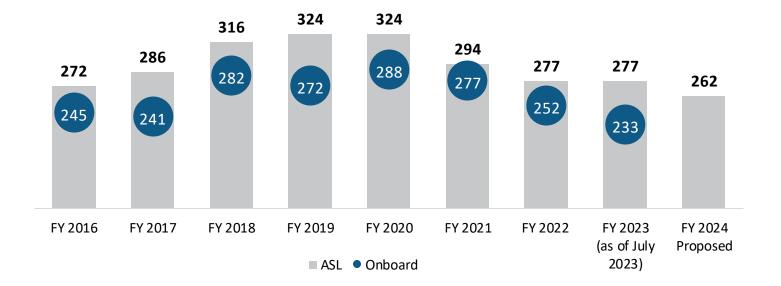
FY 2016 – FY 2022

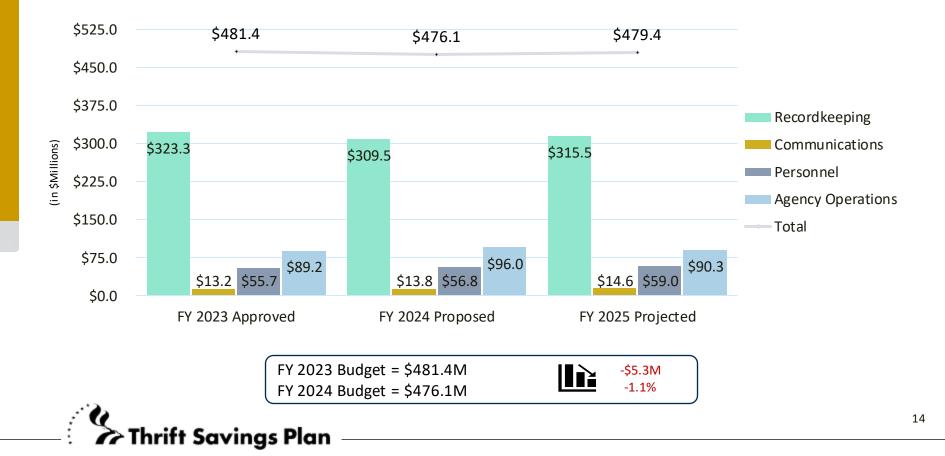

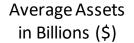


FY 2024 Budget Overview



FY 2024 Budget Relative to Plan Projections

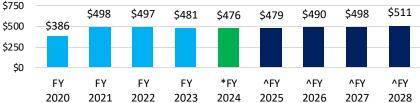

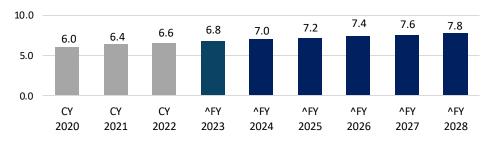


Thrift Savings Plan

Participants in Millions



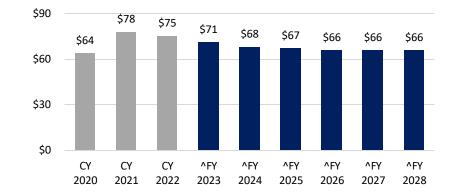
