








OEA Structure





OEA Functional Statement

- Develop and manage external communication strategies to a variety of audiences:
 - Employee Thrift Advisory Council (ETAC);
 - Media;
 - Other Federal agencies; and
 - Congress.
- FRTIB anchors its analysis of legislative proposals on whether the bills are in the sole interest of the participants and beneficiaries.



Employee Thrift Advisory Council

 Statutory; consists of 14 Federal, Postal and uniformed services representatives:

Federal Managers Association Federally Employed Women, Inc.

National Active & Retired Federal Employees Association National Association of Government Employees

Employee Thrift Advisory Council

- ETAC advises the Board and the Executive Director on investment policy and the operation of the TSP
- ETAC provides suggestions based on feedback from their membership; FRTIB shares information on upcoming TSP changes
- Generally meets:
 - Jointly with the Board once a year
 - With the Executive Director once a year

Congressional Oversight

- Congress has unfettered power to review every aspect of a Federal agency.
- Congress has access to 3 Congressional organizations to help them:
 - Government Accountability Office
 - Congressional Research Service
 - Congressional Budget Office
- For most agencies, Congress controls their budget.
- The FRTIB is one of the few agencies for which that is not true it provides a beneficial degree of predictability to Agency operations.

 - Congressman Kweisi Mfume, D-MD

Legislative Initiatives

- FRTIB sought a change for default investment fund from G Fund to ageappropriate L Fund
 - Enacted in December 2014; implemented September 2015
- FRTIB worked closely with DoD and Congress on the legislation to create the blended retirement system for uniformed service members
 - Enacted November 2015; implemented January 2018
- FRTIB sought a change to TSP withdrawal options
 - Enacted November 2017; implemented September 2019
- FRTIB successfully sought a change to the CARES Act to ensure the withdrawal provisions accommodated FERSA withdrawal language
 - Enacted in March 2020; implemented July 2020

Types of Legislation OEA Monitors

- Main categories of legislation:
 - Adding/restricting TSP Funds
 - Changing FERS defined benefit
 - Pension law changes affecting 401(k) and TSP, such as SECURE
 2.0
 - Bills that affect all agencies, such as information security requirements or Federal personnel

Legislation Introduced 118th Congress

- Currently tracking 25 pieces of legislation
- 5 dealing with the I Fund and/or the MFW, with a focus on investments in China or ESG criteria
- 1 re-defining the fiduciary responsibility of FRTIB Board members
- 6 dealing with Members of Congress' pensions
- The remainder mention the TSP but do not affect participants or investment choices, such as bills that create a similar structure for retirement savings – references the TSP's statute



Historical Number of Bills

- Number and types of bills that OEA tracks is fairly steady over each Congress
 - 117th (2021-2022) -- 38
 - 116th (2019-2020) -- 39
 - 115th (2017-2018) -- 26
