SCOPE OF SERVICES

- □ Review of financial statements of Thrift Savings Fund for the Six-Month Period Ended June 30, 2024
 - Conducted in accordance with standards generally accepted in the United States of America applicable to reviews of interim financial statements
 - Substantially less in scope than an audit
 - Not expressing an opinion regarding the interim financial statements
 - Performed analyses of financial data, principally analytical procedures
 - Inquired as to changes in internal controls over financial reporting and general computer and application controls
 - Made inquiries of Agency personnel those responsible for financial and accounting matters
 - Work performed remotely







SUMMARY OF RESULTS

- Independent Accountant's Review Report
 - We did not identify any material modifications that should be made to the June 30, 2024 interim financial statements for them to be in conformity with accounting principles generally accepted in the United States of America
- No opinion on internal controls expressed
- As part of our review procedures, we updated our understanding of internal controls
 - We did not test operating effectiveness of the controls
