

Summary Observations



Completed first major audit cycle of the Converge environment during 2023 and 2024

Overall decrease in number and severity of new recommendations since the implementation of Converge

Number of new IT recommendations decreased because of enhanced system controls in the Converge environment

Number of new process recommendations increased because of ongoing implementation of new operational processes from the legacy IT environment

Key Highlights

Account Maintenance

Recommendations cover various distinct areas of TSP operations.

Fourteen recommendations address instances of inaccurate or untimely processing of transactions or events.

Five recommendations address insufficient segregation of duties in the design of fundamental controls and lack of documentation to support transactions or events.

Four recommendations address insufficient control definitions in policies and/or procedures, and three address inconsistent control implementation in accordance with Agency policies and/or procedures.

The Agency did not concur with one open prior year (2018) recommendation but planned to implement by other means.

Mobile Device Security and Governance Controls

Recommendations pertain to Agency-managed mobile devices.

Aged IT Audit Recommendations

Four fundamental control recommendations issued prior to 2021 remain open.

The recommendations were issued prior to Converge and pertain to processes currently managed by the Agency related to contractual agreements (2*) and mobile devices (2**).

The Agency did not consider the recommendations implemented at the start of the 2025 audit cycle.

Five recommendations are under review as part of the 2025 Board Staff audit.

Three recommendations pertain to the Annuity Operations audit, which has not been performed since 2020.

Aged Process and Other Audit Recommendations

Eight recommendations issued prior to 2021 remain open.




