


# Thrift Savings Fund Statistics

## Highlights



The Thrift Savings Plan (TSP) issued more than 1.6 million 1099-Rs in January. The TSP also notified more than 334,000 participants regarding their 2026 required minimum distribution amount. In February, the TSP delivered annual statements to all participants inside My Account, as well as mailed paper copies to approximately two million participants.






**Participation Rates (current month)<sup>1</sup>**




**Historical Participation Rates by Calendar Year**



**Full Matching (5%) Rates<sup>2</sup> (current month)**




**Historical Full Matching Rates by Calendar Year**








**Uniformed Services Legacy<sup>1</sup>**




**Plan Participation (thousands)**

**Overall TSP Participation<sup>1</sup>**




**Historical Plan Participation by Calendar Year**




**Post-Separation Withdrawals Transactions  
(Partial Withdrawals & Initial Monthly Pmts)**




**Post-Separation Withdrawals Dollars  
(Partial Withdrawals & Initial Monthly Pmts)**




**Post-Separation Withdrawals Transactions  
(Ongoing Monthly Pmts)**




**Post-Separation Withdrawals Dollars  
(Ongoing Monthly Pmts)**




**Post-Separation Annuity Transactions**




**Post-Separation Annuity Dollars**

Total Distributions (Cash & Transfers) <sup>4</sup>**





### Age-Based & Hardship Transactions




### Age-Based & Hardship Dollars




### Participant-Submitted Check Transactions











### Legal Processing Dollars





## Human Interaction and Complex Service Channels (current month)



1. Counts of total contributing participants are dependent on posting dates of agency payrolls.

4. Participants may elect to transfer all or part of their single payments. If only a portion is transferred, each portion (cash and transfer) is counted separately.
5. The participant satisfaction score takes into account phone calls, web, mobile, email, and chat.
