SUBJECT: April 2016 Performance Review - G, F, C, S, I, and L Funds

INTRODUCTION

This report reviews key aspects of the investment performance of the G, F, C, S, I, and L Funds, investment manager performance and tracking error, trading costs, TSP fund performance, and L Fund participation.

BlackRock underperformed the International index by 100 basis points for the month primarily due to a fair value pricing adjustment on April 29, 2016 and underperformed by 17 basis points for the year primarily due to the net effect of fair value pricing adjustments both on December 31, 2015 and on April 29, 2016. BlackRock outperformed the Small Mid-Cap Index by 6 basis points for the month and 30 basis points for the year as a result of securities lending. BlackRock outperformed the Fixed Income Index by 14 basis points for the year due to securities lending.

The TSP Funds closely tracked the BTC Accounts for the month. The TSP Funds also closely tracked the BTC Accounts for the year.






Performance of TSP Funds Total Returns

The charts below shows the G, F, C, S, and I Fund net rates of return vs. respective benchmark index.





L Funds






Monthly Interfund Transfers C Fund



Monthly Interfund Transfers S Fund




Monthly Interfund Transfers I Fund




